The portfolio is at least 50% exposed to the MSCI world index via derivatives, while up to 25% can be invested via individual stocks and a further 25% via sector or country indexes. Minimum equity exposure at any time is 75% while minimum exposure to the euro is 85%.



The fund targets to be exposed to Equities in a range between 75% and 105% at all time. Minimum exposure to the Euro will be 85% and no more than 10% can be invested in other UCIs. Excess liquidity can be invested in high rating bonds with short duration. Overall gross exposure can go up to 200%.
