Fund Overview

CompAM Active Global Equity is an effective solution for investors looking to gain exposure to world equity markets, hedging currency exposure to the Euro. The portfolio is at least 50% exposed to the MSCI world index via derivatives, while up to 25% can be invested via individual stocks and a further 25% via sector or country indexes. Minimum equity exposure at any time is 75% while minimum exposure to the euro is 85%.

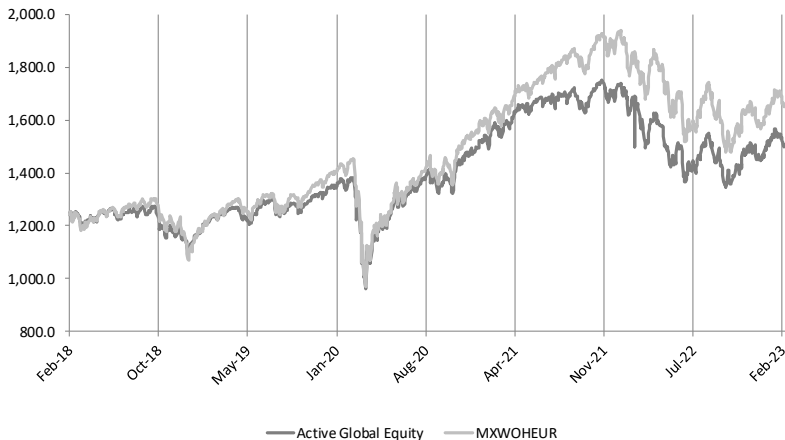

Investment Strategy

The fund targets to be exposed to Equities in a range between 75% and 105% at all time. Minimum exposure to the Euro will be 85% and no more than 10% can be invested in other UCIs. Excess liquidity can be invested in high rating bonds with short duration. Overall gross exposure can go up to 200%.
