## Fund Overview

The Acoro Global Equity Long-Only Fund is a fundamentally driven equity fund with an active and focused investment approach. At least 80% of the fund's assets are invested directly in equities. It is offering a global opportunity set in listed equities primarily in Health Care, Technology/Communications, Consumer & Industrial equities. The fund provides exposure to fundamentally, bottom-up researched equities with strong long-term growth prospects and/or attractive compounding attributes. It is seeking to invest in strong businesses which are trading at a significant discount to their intrinsic value. The fund is actively managed, and the fund manager performs regular reviews and adjusts the portfolio composition in accordance with its investment policy. The fund manager is not bound at any time to the benchmark index; therefore, the performance of the fund may differ from the indicated benchmark index.
