### Investment Strategy

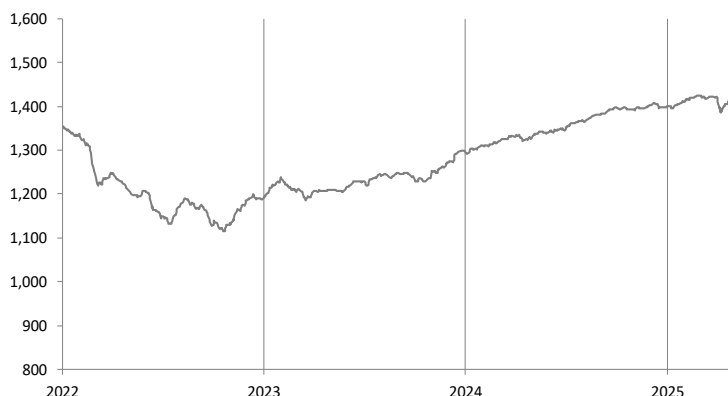
We are active investors combining a fundamental value approach with a macro overlay.
