We are active investors combining a fundamental value approach with a quantitative overlay.

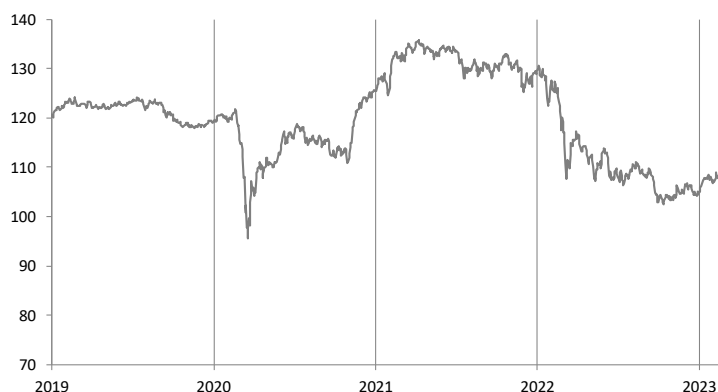
Our bottom-up stock selection process will produce sustainable alpha over the medium to long term.
