General information

CompAM FUND (the "Fund") is an investment company organised as a "*Société d'Investissement à Capital Variable*" ("SICAV") under the laws of the Grand Duchy of Luxembourg.

The Fund incorporated on 28 February 2003 in Luxembourg for an unlimited period is governed by the amended Luxembourg Law of 10 August 1915 on commercial companies and by the Part I of the amended Law of 17 December 2010 on Undertakings for Collective Investment (the "2010 Law").

The management of the Fund has been delegated to MDO Management Company S.A., a *société anonyme*, incorporated and subject to the laws of the Grand-Duchy of Luxembourg and duly authorized by the CSSF as a management company within the meaning of Chapter 15 of the 2010 Law.

The Articles of Incorporation were published in the Mémorial C, *Recueil des Sociétés et Associations* (the "*Mémorial*") on 4 April 2003, were last modified on 15 September 2015, and published in the "*Mémorial*" on 26 November 2015.

Investment in Class A, Class B, Class D, Class E, Class I, Class I (GBP), Class I (USD), Class M, Class M (CHF hedged), Class M (USD), Class S and Class S (CHF hedged) is open to any investors, including retail investors.

Investment in Class C (GBP), Class C (USD) and Class L (USD) is reserved to existing investors only, new investors are not allowed to invest in such share classes.

The Class Q is open to any type of investors, including retail investors, who purchase and sell shares through the ATFund Market.

The Class Y is reserved to other Sub-Funds of the Fund for cross Sub-Fund Investments.

The Class Z is reserved to the Investment Manager, its employees and their relatives and requires the prior approval of the Board of Directors of the Fund.

The Fund's financial year begins on 1 January and ends on 31 December of the same year.

REPORT OF THE REVISEUR D'ENTREPRISES AGREE

Opinion

We have audited the financial statements of CompAM FUND (the "Fund") and of each of its sub-funds, which comprise the statement of net assets and the portfolio as at 31 December 2020 and the statement of operations and changes in net assets for the year then ended, and notes to the financial statements, including a summary of significant accounting policies.

In our opinion, the accompanying financial statements give a true and fair view of the financial position of the Fund and of each of its sub-funds as at December 31, 2020, and of the results of their operations and changes in their net assets for the year then ended in accordance with Luxembourg legal and regulatory requirements relating to the preparation and presentation of the financial statements.

Basis for Opinion

We conducted our audit in accordance with the Law of 23 July 2016 on the audit profession (Law of 23 July 2016) and with International Standards on Auditing (ISAs) as adopted for Luxembourg by the *Commission de Surveillance du Secteur Financier* (CSSF). Our responsibilities under the Law of 23 July 2016 and ISAs as adopted for Luxembourg by the CSSF are further described in the "Responsibilities of the "réviseur d'entreprises agréé" for the Audit of the Financial Statements" section of our report. We are also independent of the Fund in accordance with the International Code of Ethics for Professional Accountants, including International Independence Standards, issued by the International Ethics Standards Board for Accountants (IESBA Code) as adopted for Luxembourg by the CSSF together with the ethical requirements that are relevant to our audit of the financial statements, and have fulfilled our other ethical responsibilities under those ethical requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Other information

The Board of Directors of the Fund is responsible for the other information. The other information comprises the information stated in the annual report but does not include the financial statements and our report of the “réviseur d'entreprises agréé” thereon.

Our opinion on the financial statements does not cover the other information and we do not express any form of assurance conclusion thereon.

In connection with our audit of the financial statements, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the financial statements or our knowledge obtained in the audit or otherwise appears to be materially misstated. If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report this fact. We have nothing to report in this regard.

Responsibilities of the Board of Directors of the Fund for the Financial Statements

The Board of Directors of the Fund is responsible for the preparation and fair presentation of the financial statements in accordance with Luxembourg legal and regulatory requirements relating to the preparation and presentation of the financial statements, and for such internal control as the Board of Directors of the Fund determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, the Board of Directors of the Fund is responsible for assessing the Fund's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the Board of Directors of the Fund either intends to liquidate the Fund or to cease operations or has no realistic alternative but to do so.

Responsibilities of the “réviseur d'entreprises agréé” for the Audit of the Financial Statements

The objectives of our audit are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue a report of the “réviseur d'entreprises agréé” that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with the Law dated 23 July 2016 and with ISAs as adopted for Luxembourg by the CSSF will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

As part of an audit in accordance with the Law dated 23 July 2016 and with ISAs as adopted for Luxembourg by the CSSF, we exercise professional judgment and maintain professional skepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Fund's internal control.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by the Board of Directors of the Fund.
- Conclude on the appropriateness of the Board of Directors of the Fund use of the going concern basis of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the Fund's ability to continue as a going concern. If we conclude that a material uncertainty exists, we are required to draw attention in our report of the “*réviseur d'entreprises agréé*” to the related disclosures in the financial statements or, if such disclosures are inadequate, to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our report of the “*réviseur d'entreprises agréé*”. However, future events or conditions may cause the Fund to cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the financial statements, including the disclosures, and whether the financial statements represent the underlying transactions and events in a manner that achieves fair presentation.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

We also provide those charged with governance with a statement that we have complied with relevant ethical requirements regarding independence, and to communicate with them all relationships and other matters that may reasonably be thought to bear on our independence, and where applicable, related safeguards.

Board of Directors Report

In hindsight, notwithstanding the outbreak of the Covid-19 pandemic and economic recessions around the globe, 2020 was characterized by very strong markets for risk assets.

The year just passed was characterized by 1) the Covid-19 pandemic, the economic lockdowns and recessions 2) a further push of monetary stimulus from the developed markets central banks and a return of strong fiscal spending around the world 2) positive equity markets (especially after the first quarter) 3) the US election and the Biden win against Trump 4) the discovery of the vaccine in November and the rebound in cyclical and value themes 5) a rebound in commodity prices 6) a weak dollar and an environment of more volatility.

Global equities had excellent performances with the MSCI Global Index in USD at +16.53% YTD. In the US most indices closed the year just passed at historical record levels. After some temporary weakness during the first quarter due to the Covid-19 outbreak, the S&P500 ended the year with a substantial +18.39%. FANG stocks pushed the Nasdaq 100 index to another record close +48% YTD. Japan, after a slow start, recovered some of the lost ground with the Nikkei 225 +18.24% YTD. After the news regarding the vaccine in November, even Europe managed to recover most of the losses and the DJ Stoxx600 was -1.44% YTD. MSCI Emerging Markets had a good year driven by the rebound in China and countries sensitive to the commodity sector, also thanks to the weaker USD. It recorded a very final quarter that pushed the index to +18.24% YTD in USD. In spite of generalized weakening of economic and earnings data, accommodative monetary policy created a positive environment for risky asset classes and fixed income investments. At the end of the year just passed, we touched again a record number of bonds yielding negative nominal rates at above 19 trillion USD, a majority of which in Europe and Japan. After a volatile first quarter, we witnessed both a rally in fixed income securities and a strong tightening of corporate spreads. The end of the year numbers are solid with the Barclays Global Agg Corp in EUR at +6.73% YTD, the Barclays Pan European High Yield at +2.77% YTD and another impressive result from US HY credits with Barclays US Corp High Yield at +7.11%. We observed a similar trend in EM fixed income with the iShares JPMorgan USD Emerging at +5.42%.

The 10y Treasuries ended the year at 0.916% (monthly low of 0.529% in July) while the 10y Bund closed at -0.569% (monthly low of -0.627% in October).

At the beginning of the year, bond markets discounted better economic conditions than actually realized during 2020. In response to the Covid induced recession, a dovish FED caused extreme tightening of the treasury curve in the first place with a flattening of the mid to long sector. At the end of the year, a benign attitude towards reflation brought a more sanguine economic outlook for a better 2021 and the curves steepened. Central Banks in Japan and Europe continued their quantitative easing, this time together with strong fiscal stimuli and a coordinated “recovery plan” at European level to restart the economy pushing towards a greener and more digital future for the region. From April onwards, Italian 10y BTPs rallied closing the year at the lows of 0.543%.

Commodities had a positive second half of the year too: in spite of the weak performance of Oil, -52.45% YTD, the Bloomberg Commodity Index had a strong second half driven by industrial metals and recovered most of the losses (-3.50% YTD)

In an environment of negative real rates and weak dollar, Gold had a good year with a performance of +24.81% in USD.

Within this context, we managed to deliver inline and satisfactory returns within the asset classes of reference of each Sub-fund.

During the year 2020, two Sub-Funds, notably CompAM-Active Market Neutral and CompAM-Double Action Focus have been liquidated. CompAM-Ginga Long/Short Japan sub-fund has been put dormant. Auriga Partners SA is the new advisor for the subfund CompAM-Active Equity Selection while Zest SA and Patrimony 1873 SA no longer act as the advisors for the subfunds CompAM-Active Liquid Strategy and CompAM-European High Yield Bond respectively.

The Management Company has made an assessment and has carried out a rigorous analysis of the possible quantitative effect on CompAM FUND and they concluded that the COVID-19 situation has not had an extraordinary impact on the Fund in terms of redemptions.


Active Emerging Credit

Active Emerging Credit Sub-fund is an unconstrained and well diversified portfolio which invests primarily in fixed income securities issued by corporate based and operating in emerging economies. The Sub-fund can also invest in emerging market government bonds, as local currency government and corporate bonds and local currency denominated supranational (such us World Bank and European Investment Bank) issues.

In 2020 the Sub-fund Class M Share gained 3.67%.

The Sub-fund managed to recover all the losses incurred during the February and March sell-off and to finish the year in positive territory. The Sub-fund displayed lower volatility compared to the main EM credit indexes and was able to achieve returns in line with those indexes even with a much lower portfolio duration, therefore not benefitting from the move lower of the Treasury yield curve. The average portfolio rating was IG throughout the year, duration was kept constant at around 4 years and the countries with the main allocation where Mexico, Brazil and Russia.

Active Global Long/Short

In 2020, its second full year as Active Global Long/Short, the Sub-fund's Class M Share delivered a net return of 5.22%.

The Sub-fund has an investment objective with the aim of achieving above-average long-term capital growth while respecting adequate diversification. For this purpose, the Sub-fund mainly invests in the following assets: shares and other equity related instruments of companies listed on stock exchanges worldwide; fixed interest and floating-rate securities, debt securities with a minimum average rating of BBB- or claims as well as other interest-bearing investments (including money-market instruments and, in particular, convertible bonds with warrants); sight deposits and deposits repayable on demand. The Sub-fund's short exposure to the above assets are achieved via contract for differences ("CFDs") and investment in listed index derivatives. No more than 10% of the Sub-fund's assets may be invested in other UCITS eligible funds. The Active Global Long/Short Sub-fund may invest up to 15% of its net assets in American depositary receipts and/or global depositary receipts. Furthermore the Sub-fund may make considerable use of financial derivative instruments, for efficient portfolio management purposes, hedging purposes including currency hedging, and investment purposes, via active investment providing exposure to securities and money-market instruments. The range of possible derivatives includes both exchange-traded and OTC instruments and in particular call and put options, futures, forwards, warrants, contracts for difference and swaps (such as total return swaps, credit default swaps, credit spread swaps, interest-rate swaps, index swaps) on securities, interest rates and currencies as well as on other financial derivative instruments and financial indices. Based on the commitment approach, the Sub-fund's risk exposure (including the risk exposure through the use of financial derivative instruments) amounts to a maximum of 210%.

Since the beginning of the year, assets under management increased by +15.9% reaching a total Net Asset Value equal to 14.56 mln Eur at the end of 2020.

Active Liquid Strategy

The Sub-fund aims to seek a consistent absolute return while placing emphasis on the preservation of capital in the medium term.

The allocation of the portfolio between the different asset classes (equities, convertible bonds, other corporate bonds, government bonds and money market instruments) may vary according to the Investment Manager's expectations.

Furthermore, the Sub-fund may make considerable use of derivative financial instruments (derivatives), or hedging purposes, in the interests of efficient portfolio management and as an active investment in securities and money market instruments and for currency hedging purposes. The range of possible derivatives includes both exchange-traded and OTC instruments and in particular call and put options, futures, forwards, warrants, contracts for difference and swaps (such as total return swaps, credit default swaps, credit spread swaps, interest-rate swaps, index swaps) on securities, interest rates and currencies as well as on other derivative financial instruments and financial indices.

The Sub-fund's total risk exposure (including the risk exposure through using financial derivatives) amounts to a maximum of 200%. The Sub-fund will seek to have an exposure to equities up to 105%.


Active European Credit

The Active European Credit Sub-fund is an unconstrained and diversified portfolio, investing mainly in debt securities of issuers domiciled in or deriving a significant part of their revenue from Europe.

In 2020, the Sub-fund Class M Share gained 4.42%.

Portfolio positioning throughout the year was modified: we started the year with slightly less than 25% of the Sub-fund net assets in cash and cash equivalent (defined as bonds with less than 3Y maturity and a rating equal or above BBB+) while the balance was evenly split between IG and HY credits. We then used the steep sell-off occurred during 1Q20 to deploy almost all of our cash and cash equivalent portion of the portfolio to increase the exposure mainly to IG credits using almost exclusively the primary market. Following this approach we were able to deliver returns slightly above the Bloomberg Barclays Eur Aggregate Corporate Index, while at the same time exhibiting lower volatility.

Active Dollar Bond

The portfolio of the Sub-fund, denominated in dollars, has been invested mainly in corporate bonds, predominantly in emerging markets and in European high yield.

In 2020, the Sub-fund Class M Share gained 5.31%.

The Sub-fund performance was in line or slightly better than global credit indexes.

Adventis Pan-Africa Equity

The Adventis Pan-Africa Equity Sub-fund mainly invests directly in companies listed or getting the majority of their revenues or having the majority of their assets from African countries, as well as certificates representative of companies listed in African countries or getting the majority of their revenues or having the majority of their assets from African countries. The Sub-fund may invest no more than 10% of its net assets in UCITS and/or other UCIs; they have to be focused on African countries.

The Investment Manager relies on Adventis SA (Pty) Ltd., Cape Town, South Africa, acting as Investment Adviser for the management of this Sub-fund.

2020 was the first full year for this Sub-fund since the appointment of the investment adviser. While performance was better than benchmarks in the early part of the year as markets were in freefall, the fund failed to fully capitalize on the rebound ending the year underperforming relevant indexes also because of the high expense ratio due to the small Assets under management (3.1 million as of year end).

SB Convex

The SB Convex Sub-fund invests its assets in listed equities worldwide, debt securities, money markets instruments and deposits. Moreover the Sub-fund may invest up to 20% of its net assets in eligible assets with underlying gold such as but not limited thereto physically-backed exchange traded notes, physically-backed exchange traded commodity.

In 2020 the Sub-fund returned a positive performance of +20.25% (Class I Share).

The Investment Manager relies on Alto Adige Banca S.p.A. - SÜDTIROL Bank AG as Investment Adviser for the management of this Sub-fund.

SB Equity

The SB Equity Sub-fund mainly invests in listed equities worldwide (such assets shall represent, under normal market conditions, between 30% and 100% of the Sub-fund's net assets) as well as in other eligible assets such as, but not limited to, debt or debt securities, Money Market Instruments and deposits, without any geographical or economic restriction. The policy is realized mainly by investments in other UCITS.

In 2020 the Sub-fund returned a positive performance of +9.50% (Class I Share).

The Investment Manager relies on Alto Adige Banca S.p.A. - SÜDTIROL Bank AG as Investment Adviser for the management of this Sub-fund.

SB Flexible

The SB Flexible Sub-fund mainly invests in listed equities worldwide (such assets shall represent, under normal market conditions, between 15% and 60% of the Sub-fund's net assets) as well as in other eligible assets such as, but not limited to, debt or debt securities, Money Market Instruments and deposits, without any geographical or economic restriction. The policy is realized mainly by investments in other UCITS.

In 2019, the Sub-fund returned a negative performance of -1.18% (Class I Share).

The Investment Manager relies on Alto Adige Banca S.p.A. - SÜDTIROL Bank AG as Investment Adviser for the management of this Sub-fund.

SB Bond

The SB Bond Sub-fund mainly invests in debt securities of any country of issuance even low rated and may also invest up to 10% of its net assets in listed equities worldwide. The policy is realized mainly by investments in other UCITS.

In 2019, the Sub-fund had a negative performance of -1.28% (Class I Share).

The Investment Manager relies on Alto Adige Banca S.p.A. - SÜDTIROL Bank AG as Investment Adviser for the management of the Sub-fund.

Active Bond Plus

The Active Bond Plus Sub-fund mainly invests (directly or indirectly) in debt securities of any country of issuance even low rated and invests up to 20% of its net assets in listed equities worldwide. The Sub-fund may also use, for the purpose of efficient portfolio management and proxy hedging, currency forwards and options, as well as listed futures (and related options) on government bonds, equities, interest rates and currencies.

In 2020, the Sub-fund Class I Share lost -0.75%.

Notwithstanding the net positive contribution to the Sub-fund performance of its bond portion of the portfolio, the equity component, even if it was kept below the maximum threshold of 20% for most of the time, contributed negatively. Therefore, the Sub-fund was unable to fully recover the losses incurred during the 1Q20 sell-off.

European High Yield Bond

The European High Yield Bond Sub-fund invests up to 100% in bonds or other fixed income transferable securities issued by corporations, by countries' treasuries and/or government agencies and/or by supranational organizations, such as EBRD or World Bank or the EIB, domiciled in or deriving a significant part of their revenues from Europe, and which rating may be below investment grade.

The Sub-fund may invest up to 75% of its net assets in non-investment grade and unrated securities, including bonds issued in European Emerging Countries.

The minimum average rating calculated based on the Bloomberg Composite of the rated securities and cash of the Sub-fund net asset value in which the European High Yield Bond Sub-fund invests shall be B. The Investment Manager allocates its own internal rating to the unrated securities in which the European High Yield Bond Sub-fund invests. The minimum average internal rating of those securities shall be B. In addition the Sub-fund may invest up to 20% of the Sub-fund's net assets in debt securities issues, whose issued amount is lower than 100 million Euro or equivalent; issued by corporations, by countries' treasuries and/or government agencies and/or by supranational organizations, such as EBRD or World Bank or the EIB, domiciled in or deriving a significant part of their revenues from Western Europe, which rating may be below investment grade.

In addition, the Sub-fund may also invest up to 10% of its net assets in listed equities, equity related-securities and derivatives worldwide. The European High Yield Bond Sub-fund may further invest up to 10% of its net asset value in distressed securities and securities in default. Investments in contingent convertibles ("CoCos") shall not exceed 20% of its net asset value.

The Sub-fund maintains a currency exposure to the Euro of at least 70%, using hedging techniques where necessary.

In 2020 the Sub-fund delivered a positive return of +3.94%.

The Investment Manager relied on Patrimony 1873 S.A. as Investment Adviser for the management of the Sub-fund until December 31st, 2020, effective date of the termination of the relevant advisory agreement.

Global Diversified

The Sub-fund invests a percentage between 20% and 100% of its assets in debt securities issued by corporations, by countries' treasuries and/or government agencies and/or by supranational organizations (such as EBRD or World Bank or the EIB) of any country of issuance even Emerging Markets, even low and not rated. More specifically, the Global Diversified Sub-fund may invest up to 10% of its assets in not rated bonds. The investment of the Global Diversified Sub-fund in not rated together with low rated bonds will in no case exceed 30% of its assets. In addition the Global Diversified Sub-fund may invest up to 40% in UCITS and/or other UCIs. The Global Diversified Sub-fund may also invest up to 50% of its net assets in listed equities or equities related securities worldwide (such as certificates representative of equities or equity indices). The Global Diversified Sub-fund may, on an exceptional and temporary basis, hold up to 100% of its assets in cash and cash equivalents.

In 2020, the Sub-fund returned a negative performance of -3.27% for the Class M Share.

Assets under management were 23.05 million Euro at year end.

The Investment Manager relies on Amaranto Investment SIM S.p.A. as Investment Adviser for the management of the Sub-fund.

Active Equity Selection

The Active Equity Selection Sub-fund invests primarily in financial derivatives and a concentrated number of equities listed or issued in the European Union with a bottom-up approach to stock selection.

The Active Equity Selection Sub-fund seeks to have an exposure to the above mentioned European equities or equity-related securities that range between 75% and 100% of its net assets by using mainly, although not exclusively, financial derivative instruments. Financial derivatives instruments used for such purposes

mainly, but not exclusively, consist of futures on Eurostoxx 50, futures on Eurostoxx 600, ETFs replicating the performance of Eurostoxx 50 and Eurostoxx 600. The Sub-fund does not hedge currency risk for equities denominated in currencies other than the Euro.

In 2020, the Sub-fund's Class M Share delivered a negative return of -3.79%. It was the fourth full year with the current investment strategy. For the first time in four years, the Sub-fund underperformed its benchmark, the EURO STOXX 50 Net Return EUR, by 58 basis points.

Assets under management at the end of 2020 stood at 11.59 mln EUR.

The Investment Manager relies on Auriga Partners SA as Investment Adviser for the management of the Sub-fund.

Active Global Equity

The Active Global Equity Sub-fund targets an outperformance of the MSCI world index hedged in EUR, by taking exposure to equity markets via indexes and single stocks.

During 2020, the Sub-fund delivered a positive performance of +11.24% (Class M Shares) for the year. Since inception of the new strategy the Sub-fund underperformed its benchmark by -5.28%. The portfolio manager's is entering 2020 with a constructive view on equity markets, being invested in line versus the benchmark.

AUM stood at 34.35 million Euro as of year-end.

Active Market Neutral

The Active Market Neutral Sub-Fund invests primarily in equities listed or issued in the European Union actively managing directional exposure to the equity market via portfolio risk management techniques carried out with discretionary hedging. The purpose of this Sub-Fund is to achieve returns similar to the long run returns available in the equity markets, with reasonable volatility and a limited drawdown risk.

In April 2020, in consideration of the fact that the level of assets of the Sub-fund was low and the efforts made to relaunch it didn't produce the desired effects, the Board decided to liquidate it.

Flexible Bond

The Flexible Bond Sub-fund mainly invests (directly or indirectly) in debt and/or debt related securities of any country of issuance even low rated. The Flexible Bond Sub-fund may also invest (directly or indirectly) up to 30% of its net assets in listed equities or listed equity-related securities worldwide and/or in asset-backed securities and/or mortgage-backed securities.

Investments in asset-backed securities and/or mortgage-backed securities don't however not represent more than 20% of the assets of the Flexible Bond Sub-fund. On an ancillary basis, the Flexible Bond Sub-fund may be able to invest in other eligible assets other than debt or debt related securities such as, but not limited to, time deposits and Money Market Instruments. No more than 10% of the assets of the Flexible Bond Sub-fund may in aggregate be invested in units or shares of other UCITS and/or UCIs.

During 2020, the Sub-fund delivered a positive return (Class Q) of +0.97%.

Cadence Strategic Asia

The Sub-fund's objective is to target returns in excess of nominal Asian GDP growth (gross domestic product) over the medium to long term. It does so by investing in a concentrated portfolio of companies capable of sustaining high economic returns and which are undervalued in relation to their future cash generating ability. The Sub-fund's investment strategy is unconstrained by any benchmark index and is focused on achieving absolute returns over the longer term. The unconstrained and concentrated nature of the Sub-fund means that over shorter time periods, its returns are likely to diverge meaningfully from the performance of conventional benchmark indices.

Asian markets finished the year strongly as investors responded to positive news flow around Covid vaccines and the potential for a normalization of economic activity over the course of 2021. The Cadence Strategic Asia fund (US\$ L Class) delivered a return of 27.1% for the year, that compares with a return from the MSCI Asia ex Japan Net Total return index of 25.1%

Assets under management at the end of 2020 stood at 155 mln Eur.

The Investment Manager relies on Cadence Investment Partners LPP, Edinburgh, acting as Investment Adviser for the management of this Sub-fund.

Equilibrium

The Equilibrium Sub-fund invests principally in UCITS and/or other UCIs, including in other Sub-funds of the Fund or others Sub-funds managed by the same investment manager. The Equilibrium Sub-fund invests its assets, either directly or indirectly, in listed equities (such assets shall represent, under normal market conditions, between 0% and 55% of the Sub-fund's net assets) as well as in other eligible assets such as, but not limited to, debt securities, Money Market Instruments, deposits, etc. The Equilibrium Sub-fund may further invest in securities issued by companies investing in or managing real estate assets or which are active in the real estate field. Investment shall be made without any geographical or economic restriction. The maximum management fees that may be charged to both the Sub-fund and to the UCITS and/or other UCIs in which the Equilibrium Sub-fund may invest shall not exceed 4.90 % of the Equilibrium Sub-fund's net assets. In addition, the Equilibrium Sub-fund may invest up to 20% of its net assets in eligible assets with underlying commodities such as, but not limited thereto, physically-backed exchange traded notes, physically-backed exchange traded commodity.

2020 was the fourth year of trading for the Equilibrium Sub-fund strategy and the third full year of operation. The Sub-fund delivered a negative performance of -5.78% (Class I Shares). At the end of the year, assets under management stood at 9.49 Eur mln.

Global Flexible Blend

The investment process is aimed at creating added value by implementing the investment policy by the Investment Manager. The investment style is flexible with a total return goal. The Global Flexible Blend Sub-fund invests between 20% and 100% of its net assets in listed equities or equities related securities worldwide, such as but not limited to certificates representative of equities or equity indices.

The Global Flexible Blend Sub-fund may also invest a percentage up to 80% of its assets in debt securities issued by corporations, by countries' treasuries and/or government agencies and/or by supranational organizations, such as EBRD or World Bank or the EIB, of any country of issuance, even Emerging Markets. Investments in bonds may be made in low and/or not rated bonds. Low rated bonds are deemed to be bonds which investment grade is below BB. More specifically, the Global Flexible Blend Sub-fund may invest up to 15% of its assets in not rated bonds. The investments of the Global Flexible Blend Sub-fund in not rated together with low rated bonds, which can include investments in distressed securities and securities in default up to 5%, will in no case exceed 30% of its assets.

In 2020 the Sub-fund delivered a negative performance of -1.41% (Class Q Shares).

Ginga Long/Short Japan

The investment objective of the Ginga Long/Short Japan Sub-fund was to achieve above-average long-term capital growth with limited risks while ensuring an adequate investment diversification, primarily by achieving long and short exposure to equities issued by companies having their principal domicile in Japan. The Sub-fund was co-managed by Compass Asset Management S.A., Switzerland, that takes care of investing the liquidity and performing the currency hedging into euro of the Sub-fund and Stats Investment Management Co. Ltd., Japan, that operates the Equity Long/Short Japan strategy.

During the first quarter of the year 2020, Stats Investment Management Co. Ltd. Japan decided to end the relationship with Compass Asset Management SA and the management of the Sub-fund as well to focus on different types of project; at the same time, Sub-fund has been redeemed and the Directors decided to put the Sub-fund dormant of the time being.

Double Action Focus

The investment process is aimed at creating added value by implementing the investment policy by the Investment Manager. The Double Action Focus Sub-fund invests its assets, either directly or indirectly, in listed equities (such assets shall represent, under normal market conditions, between 40% and 100% of the Double Action Sub-fund's net assets) as well as in other eligible assets such as, but not limited to, debt securities having a minimum average rating of BBB-, Money Market Instruments, deposits, etc. Investments shall be made without any geographical or economic restriction. On an ancillary basis, the Double Action Focus Sub-fund invests, directly and/or indirectly through other UCITS or UCIs in Russia and China. Investments in these countries will not exceed 20% of the net assets of the Double Action Focus Sub-fund. The Double Action Focus Sub-fund may also invest directly and/or indirectly through other UCITS or UCIs up to 20% in aggregate of its net assets value in emerging markets of Latin America, Far East and Europe Middle East and Africa ("EMEA").

In May 2020, in consideration of the low level of assets and scarce growth prospects, following a total redemption of the Sub-fund shares, the Directors decided to liquidate it.

Board of Directors Report- Outlook for 2021

Looking backwards at the year just passed, we can say that 2020 was a challenging year characterized by strong positive returns for most asset classes in an environment of high uncertainty due to Covid-19, accommodative central banks, government spending to support the economy amid slowing global growth and a weaker US dollar.

Current volatile economic environment and risks of prolonged recessions are mitigated by enormous stimuli, both monetary and fiscal, and better prospects for a normalization at the end of the pandemic during this year. The Board and the Manager continue to watch the efforts of governments to contain the spread of the virus and monitor the economic impacts, if any, on the companies in our portfolio.

Central banks greatly influence the absolute level and the shape of the government curves, so the key indicators to watch will be developed currencies, a scenario of competitive devaluation that would benefit real assets. Despite signs of exuberance in certain segments financial markets, all these factors support risky assets around the World in the medium term. In a nutshell, all asset classes now are correlated and linked to the big financial repression experiment around the world that keeps the real rates at low or negative levels.

The positive results of equity markets in 2020 occurred notwithstanding generalized negative earnings growth trend. Consequently, in the Developed world, and the US in particular, the re-rating of equity markets, with prices up and earning down, was pretty significant. Besides developed markets, one area where we see opportunities is the Asian equities ex-Japan complex. The relative cheapness of EM, especially Asia, compared to DM makes us feel more constructive on EM equities for the coming year, especially should the commodities prices consolidate their rally and the USD weakness continue. It is our expectation that other areas such as Asia Ex-Japan and Domestic US will get back in favor consolidating the market rotation and a scenario of asset reflation would continue to unfold. Notwithstanding lingering uncertainties linked to Covid-19 spread in the region, even European assets should benefit from this process.

Turning to fixed income assets, government bonds delivered excellent returns in spite of years of a very low interest rates environment. Still, real rates are low compared to history and there are some risks that we might have to face a scenario of rising inflation in the coming years. Therefore, it is difficult to envision attractive returns in government bonds, especially when rates are negative across the European government bond yield curves. After over 30 years bull market in rates, we feel that in 2021 the risks in fixed income are skewed again on the downside. We believe that keeping short durations and some steepening exposure are still a valid strategy in the current environment.

As far as credit markets are concerned we are still constructive on global investment grade but selectively so. European and US high yield market reached very tight levels while emerging market debt present a more diverse scenario with some areas, such as Latam, which look decently attractive to us, although selectively, mainly based on valuations.

On gold and GDX, we believe that they still represent interesting areas to invest in but have somewhat lost the diversification benefits they showed in 2020 during the first phase of the pandemic. As diversification tools, we continue to have positions in Swiss Franc and Swedish Krona, Norwegian Krona and Aussie Dollar and, selectively, some EM local currencies, while being negative on the Dollar against the major developed currencies.

Notes to the financial statements**Note 1 - Accounting Policies**

a) Presentation of the financial statements

The financial statements of the Fund are established in accordance with the Luxembourg legal and regulatory requirements concerning Undertakings for Collective Investment ("UCIs") and generally accepted accounting principles in Luxembourg.

b) Valuation of securities

- The value of assets, which are listed or dealt in on any stock exchange, is based on the last available price on the stock exchange, which is normally the principal market for such assets.

- The value of assets dealt in on any regulated market is based on the last available price.

- In the event that any assets are not listed or dealt in on any stock exchange or on any other regulated market, or if, with respect to assets listed or dealt in on any stock exchange, or other regulated market as aforesaid, the price as determined pursuant to sub-paragraphs here above is not representative of the fair market value of the relevant assets, the value of such assets is based on the reasonably foreseeable sales price determined prudently and in good faith by the Board of Directors of the Fund.

- The liquidating value of futures or forward foreign exchange contracts and warrants traded on exchanges or on other regulated markets is based upon the last available settlement prices of these contracts on exchanges and regulated markets on which the particular future or forward foreign exchange contracts are traded by the Fund; provided that if a future or forward foreign exchange contract could not be liquidated on the day with respect to which net assets are being determined, the basis for determining the liquidating value of such contract is such value as the Board of Directors of the Fund may deem fair and reasonable.

- Units or shares of open-ended UCI are valued at their last determined and available net asset value or, if such price is not representative of the fair market value of such assets, then the price is determined by the Board of Directors of the Fund on a fair and equitable basis. Units or shares of a closed-ended UCI are valued at their last available stock market value.

- The market value of the contracts for difference is determined by the traded price on the exchange on which the underlying securities or assets are traded or admitted for trading less the financing costs attributable to the relevant contract. For underlying securities traded on markets closing after the time of the valuation, last known prices as of this time or such other time may be used.

- The value of any cash on hand or deposit, bills and demand notes and accounts receivable, prepaid expenses, cash dividends and interest declared or accrued as aforesaid and not yet received is deemed to be the full amount thereof, unless in any case the same is unlikely to be paid or received in full, in which case the value thereof is arrived at after making such discount as may be considered appropriate in such case to reflect the true thereof.

- All other securities and other assets are valued at fair market value, as determined in good faith pursuant to procedures established by the Board of Directors of the Fund or a committee appointed to that effect by the Board of Directors of the Fund.

c) Conversion of the acquisition cost of securities in the portfolio

For securities expressed in currencies other than the reference currency of the Sub-Fund, the conversion of the acquisition cost is calculated based on the closing exchange rates of the day of purchase.

Notes to the financial statements (continued)**Note 1 - Accounting Policies (continued)**

- d) Net realised profit/(loss) on sale of investments

Net realised profits or losses made on the sales of investments are calculated according to the average cost method.

- e) Investment income

A dividend income is recognised on an ex-dividend basis and is recorded net of withholding taxes.
Interest income is recorded on an accrual basis.

- f) Conversion of foreign currencies

Cash at banks, other net assets and the market value of the securities in portfolio expressed in currencies other than the reference currency of the Sub-Fund are converted into this currency at the exchange rate prevailing as at 31 December 2020. Income and expenses expressed in currencies other than the reference currency of the Sub-Fund are converted into this currency at the exchange rate prevailing on the date of the transaction. Exchange gains and losses are recorded in the Statement of Operations and Changes in Net Assets under the heading net realised profit/(loss) on currencies.

- g) Combined financial statements

The accounting records of each Sub-Fund are kept in the reference currency of the Sub-Fund and the Combined Statement of Net Assets is presented in euros (“EUR”).

The combined statements correspond to the sum of the statements of each Sub-Fund which, where applicable, are converted in EUR with the exchange rate as at 31 December 2020. The differences of exchange rates between 31/12/2019 and 31/12/2020 are recorded in Statement of Operations and Changes in Net Assets under the caption Conversion difference.

Forward foreign exchange contracts are valued at forward market rates for the remaining period from valuation date to the maturity of the contract. Net realised profit / (loss) and change in unrealised appreciation / (depreciation) on forward foreign exchange contracts are recorded in the Statement of Operations and Changes in Net Assets. The unrealised profit/loss is recorded in the Statement of Net Assets.

i) Futures contracts

Futures contracts are valued at their last known traded price on the stock exchanges or regulated markets on which they are traded. Net realised profit / (loss) and change in unrealised appreciation / (depreciation) on futures contracts are recorded in the Statement of Operations and Changes in Net Assets. The unrealised profit/loss is recorded in the Statement of Net Assets.

j) Contracts for difference (CFD)

In a contract for difference, two parties commit to exchange payments, which replicate the economic consequences of holding a long or short position in the underlying security. Contracts for difference are valued at the closing price of the underlying instrument less the financing costs attributable to the relevant contract. When a contract for difference

is concluded, the Sub-Fund may be required to deposit an amount (“initial margin”) that corresponds to a pre-agreed percentage of the contract price in cash and/or other assets with the broker. The unrealised profit/loss is recorded in the Statement of Net Assets. Net realised profit / (loss) and change in unrealised appreciation / (depreciation) on contracts for difference are recorded in the Statements of Operations and Changes in Net Assets.

k) Option contracts

Option contracts quoted on an official stock exchange or on another regulated market are valued according to the last known market price or, if there are several markets, according to the last known price of the principal market. Net realised profit / (loss) and change in unrealised appreciation / (depreciation) on option contracts are recorded in the Statement of Operations and Changes in Net Assets.

Note 2 - Investment Management fees

In remuneration for its services, the Investment Manager is entitled to receive an annual investment management fee payable monthly and calculated on the average net assets of each Sub-Fund during the relevant month.

A shareholder service fee up to 0,01% per annum for each Sub-Fund (except for CompAM FUND - Active Liquid Strategy, for which it is 0,30%) is payable to the Investment Manager in compensation of the services related to addressing shareholders' queries regarding the investment strategy and other information related to the relevant Sub-Fund. The shareholder service fee is payable out of the assets of the relevant Sub-Fund monthly in arrears and calculated as a percentage of the average Net Asset Value per class of Shares which have been subscribed.

A services agreement in relation to the services provided by the Investment Manager to the CompAM FUND - Active Liquid Strategy Sub-Fund shall be available for inspection at the registered office of the Fund and the Investment Manager during usual business hours.

Total amount of any rebates of the management commissions applied on underlying UCITS or UCI managed by third companies are transferred to the respective Sub-Fund on a quarterly basis and recorded in the Statement of Operations and Changes in Net Assets under the heading "Other income".

With regard to the investments within the same umbrella structure, there is no duplication of management/subscription or repurchase fees.

As a remuneration for its advisory services, the Investment Adviser is paid an investment advisory fee out of the investment management fee received by the Investment Manager.

Note 3 - Depositary, Paying, Administrative, Registrar and Transfer Agent fees

The Depositary, Paying, Administrative, Registrar and Transfer Agent is entitled to receive out of the assets of each Sub-fund a fee up to 0,21% per annum of the average quarterly NAV thereof during the relevant quarter and payable quarterly in arrears, subject to a minimum of EUR 25 000 - per annum in relation to any Sub-fund.

Note 4 - Management Company fees

The Management Company is entitled to receive an annual Management Company fee payable quarterly and calculated on the quarterly average Net Assets of the respective Sub-Fund of the previous quarter as follows:

- 0,07% per year for Total Net Assets up to €250 million;
- 0,06% per year for Total Net Assets between €250 million and €500 million;
- 0,05% per year for Total Net Assets between €500 million and €1 billion;
- 0,04% per year for Total Net Assets above €1 billion.

The Management Company is entitled to a minimum fee of €120 000 per year.

Moreover, for the compliance monitoring services provided, the Management Company will be entitled to an annual fee of €1 000/Sub-Fund, subject to a fixed based fee of €20 000 per year.

Note 6 - Subscription Tax

The Fund is governed by Luxembourg Laws.

Pursuant to the 2010 Law, the Fund is subject to an annual subscription tax ("taxe d'abonnement") of 0,05% which is payable quarterly and calculated on the basis of the Net Assets of each Sub-Fund on the last day of each quarter.

A reduced tax rate of 0,01% per annum of the Net Assets is applicable to classes of Shares which are only sold to and held by Institutional Investors as well as to certain Sub-Funds investing exclusively in money market instruments which is payable quarterly and calculated on the basis of the Net Assets of each Sub-Fund on the last day of each quarter.

Pursuant to Article 175 (a) of the amended Law of 17 December 2010, the Net Assets invested in Undertakings for Collective Investment already subject to the "taxe d'abonnement" are exempt from this tax.

Note 7 - Transaction Costs

For the year ended 31 December 2020, the Fund incurred transaction costs which are included in the acquisition cost (composed of broker fees and stamp duties) relating to purchases or sales of investment securities and/or other eligible assets. Depositary transaction fees are recorded in the Statement of Operations and Changes in Net Assets under the caption "Depositary transaction fees".

Not all transaction costs are separately identifiable. For fixed income investments, forward foreign exchange contracts and other derivative contracts, transaction costs are included in the purchase or sales price and are not separately disclosed.

On 18 March 2020 the Board of Directors of the Fund decided to place the Sub-Fund CompAM FUND - Double Action Focus into liquidation.

Note 14 - Subsequent Events

MDO Management Company SA has changed the name to Waystone Management Company (Lux) S.A. with effective date as of 3 February 2021.

REMUNERATION POLICY

The management company has adopted a remuneration policy pursuant to applicable laws and regulations with the objective to ensure that its remuneration structure is in line with its interests and those of the collective investment schemes it manages and to prevent risktaking which is inconsistent with the risk profiles, rules or articles of incorporation or management regulations of the collective investment schemes it manages.

Details of the remuneration policy of the management company, including the persons in charge of determining the fixed and variable remunerations of staff, a description of the key remuneration elements and an overview of how remuneration is determined, is available at <http://www.mdo-manco.com/about-us/legal-documents>.

With respect to the financial year ended 31 December 2020 (as of that date, the management company had a headcount of 73 employees), the total fixed and variable remuneration paid by the management company to its employees amounted to EUR 5,236,688 and to EUR 1,448,313 respectively. The total remuneration paid by the management company to senior management and members of its staff whose actions have a material impact on the risk profile of the collective investment schemes managed amounted to EUR 3,569,815.

The remuneration committee of the management company has reviewed the implementation of the remuneration policy and has not identified any deficiency in that respect. Moreover, the current version of the remuneration policy was updated and approved by the board of directors in the course of the financial year ended 31 December 2019, the current version being dated July 2019. There was no identified need for an update of the policy in the course of the financial year ended 31 December 2020, and a similar assessment will be performed in 2021.

SECURITIES FINANCING TRANSACTIONS REGULATION

The Securities Financing Transaction Regulation (SFTR) 2015/2365 on transparency of securities financing transactions and of reuse came into force on 12 January 2016 and introduces new disclosure requirements for securities financing transactions and total return swaps.

A securities financing transaction is defined as per Article 3(11) of the SFTR as:

- a repurchase/reverse repurchase agreement,
- securities or commodities lending and securities or commodities borrowing,
- a buy-sell back transaction or sell-buy back transaction, or
- a margin lending transaction.

As at 31 December 2020, the Fund is not impacted by the Securities Financing Transactions Regulation.

GLOBAL EXPOSURE

As part of this risk management process, the global exposure of each Sub-Fund of the Fund is measured and controlled using the commitment approach.
